- **Application Deadline** – Applications for the Board of Zoning Appeals public hearings must be received at least **Thirty (30) Days** prior to the date of the Board of Zoning Appeals meeting.
- **Public/Legal Notification** – Public Notification for the Board of Zoning Appeals public hearings must be published in the Hendricks County Flyer and the Republican newspapers at least **Ten (10) Days** prior to the date of Board of Zoning Appeals meeting.
 - ❖ *The Plan Commission staff will place the legal advertisement for the petitioner on or before the date shown above.*
- **Written Notification & Sign Posting** – Written Notification to surrounding property owners for the Board of Zoning Appeals public hearings must be mailed by certified mail and postmarked at least **Ten (10) Days** prior to the date of the Board of Zoning Appeals meeting. Posting of the sign regarding the case being heard must also be posted at least **Ten (10) Days** prior to the meeting. ****Proof of these mailings and sign posting, along with the affidavits, must be filed with the planning department (1) week prior to the Board of Zoning Appeals meeting date to avoid continuance.****
 - ❖ *Written Notification to surrounding property owners and the posting of the sign on the said property is the responsibility of the Petitioner.*
