Final Reading: Ordinance 2019-29: 2020 Salaries and Benefits

*Approved. Establishes salaries and benefits as approved in the 2020 budget. Includes pay grade changes and additional increases above 3% as proposed in the Parks and Public Works budgets.*

Introduction, Suspension of Rules and Final Adoption: Ordinance 2019-30: End of Year Re-appropriation Ordinance

*Approved. End of year ordinance that transfers account line budget to match expenses.*

Introduction: Ordinance 2019-31: Deaf and/or Blind Child Sign Policy

*Suspended rules to adopt it on final reading. Approved. Establishes policy for the installation of deaf and or blind child advanced warning signs in the right of way.*
