1. You have **30** days from the date on your citation to return this completed form to the court office.

2. IF YOU WISH TO ADMIT TO THE CHARGE:

a. Complete this form and mail it and payment to the above address within 30 days.

b. **NO CASH OR PERSONAL/BUSINESS CHECKS.**

We only accept money order, cashier's check and debit cards. We do NOT accept online or phone payments. Credit card transactions are only available during operating hours. There is a \$3.00 charge to use the debit/credit card machine. Receipts are not mailed unless you include a self-addressed, stamped envelope.

3. IF YOU WISH TO DENY THE CHARGE:

a. Complete this form and circle "C" on the reverse side of this form. Include a self-addressed, stamped envelope.

b. Each side is allowed only one continuance, excluding emergencies. The request for a continuance must be in writing and received into the court office 24 hours prior to the court date. We do not accept denials by telephone.

4. If you fail to pay your ticket within 30 days, you will need to include an additional \$25.00 late fee.

5. If you require a 30 day extension to pay your ticket, you may fill out an extension form at the court office. Extensions are NOT granted over the phone.
