- **Preliminary Consultations** – Preliminary Consultations are required for
- **Application Deadline** – Applications for the Board of Zoning Appeals public hearings must be received at least **Thirty (30) Days** prior to the date of the Board of Zoning Appeals meeting.
- **Public/Legal Notification** – The Planning Staff is responsible for placing the Public/Legal Notification for the Board of Zoning Appeals public hearings and will be published in the Hendricks County Republican at least **fourteen (14) days prior** to the date of the Board of Zoning Appeals meeting.
- **Written Notification & Sign Posting** – The Petitioner is responsible for the Written Notification & Sign Posting. Written Notification to surrounding property owners for Board of Zoning Appeals public hearings may be sent by first class mail and postmarked at least **fourteen (14) days** prior to the date of the Board of Zoning Appeals meeting. Posting signs for each case being heard must also be completed at least **fourteen (14) days** prior to the meeting. **\*\*The signed and notarized affidavits will serve as proof of the Written Notification & Sign Postings and must be filed with the Planning Staff prior to the Board of Zoning Appeals meeting to avoid continuance.**
